"You must admire a team like Kansas City. Down 21 points and they never gave up. They just played that much harder and kept coming back. We were very fortunate to get out of town alive. Obviously their defense got tougher, because we only scored one touchdown offensivelly in the second half and we were still trying to score."

"To be honest, I really don't know for sure the specifics, but we did make some
adjustments. You really need to ask Rod Rust (defensive coordinater) about it.
We did some things, though, to help our strong safety from being man-to-man
on Winslow when he was wide."

"We made some mistakes. Yes, we moved the ball pretty well, but I am not impressed with the statistics. I would be more impressed if we had won.

(Asked about playing San Diego close and how it made him feel) "I will tell you what I told the team. There is a lot of fight on this team and don't lose it. But we have to play a lot better against the good teams if we are going to be in it...we made some costly mistakes. I know you hear that all the time, from the losing coach, but it is true.

"Yes, we had a lot of injuries. Mike Williams will have his knee examined and we are not sure how extensive it is, but it may require surgery. Carlos (Carson) has a fractured of a bone (fibula) in his leg. Art Still suffered ligament damage (knee) and the doctor told me it would be a few days before he can tell if it is a tear.

"Pass interference penalties are a travesty on the game. They are reductous It is electricution for stealing a loaf of bread. It is a stupid rule and just awards a touchdown to a team. They have got to stop it or do something about it or will make a mockary of the game.
